ELECTION NOTICE

Fair Work (Registered Organisations) Act 2009

The Registered Organisation Commission has made arrangements with the Australian Electoral Commission for elections to be conducted for the offices set out in this notice.

NOMINATIONS: Nominations are now called for the offices listed in Attachment A of this notice. Nominations must be in writing and comply with the registered rules of the Union. Nominations can be lodged at any time from 30 July 2018 and must reach the appropriate Returning Officer at his/her office, postal address or email box not later than 5:00 pm (local time¹) on 14 August 2018. Late nominations will not be received.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Union's rules prior to lodging nominations.

Nominations cannot be withdrawn after 5:00 pm (local time¹) on 14 August 2018.

NOMINATION FORMS: Nominations are available from the appropriate Returning Officer or from the Union. Nomination forms are also available on the Union's or AEC website.

CANDIDATES' STATEMENTS AND PHOTOGRAPHS (Rule 47.52): Candidates are advised that they may, at the time of nominating, submit to the Returning Officer at his office or postal address not later than 5:00pm on 14 August 2018, a typewritten statement which shall not exceed 200 words and a list of offices and /or positions currently and/or previously held in the Union or in any union which is amalgamated into the Union or in a State Registered Union which is associated with the Union and a black and white passport size photograph of the candidate. (Statements should be provided in Word format together with photographs in jpeg format via email to the relevant Returning Officer).

BALLOT: The ballot, if required, will be conducted by post and open on 11 September 2018 and close at 10:00 am (local time¹) on 8 October 2018.

SCRUTINEERS: Candidates may appoint a scrutineer. Scrutineer appointment must comply with the rules of the Union and be received in writing by the appropriate Returning Officer not later than the closing of the ballot at 10:00 am (local time¹) on 8 October 2018.

CHANGED ADDRESS: Advise the Union now.

Note: Copies of the AEC's election reports can be obtained from the organisation or from the Returning Officer after the completion of the election.

¹ Local time refers to the time zone (be it ACST, AEDT, AEST, AWST or other) at the Returning Officer's location, who are specified in this notice, and not that of the candidate's and/or member.
