Candidates' Statements (Rule 47.52): Candidates are advised that they may, at the time of nominating, not later than 12 noon (AEDT) on Tuesday, 7 March 2017 submit to the Returning Officer, a typewritten statement which shall not exceed 200 words and a list of offices and/or positions currently and/or previously held in the Union or in any union which is amalgamated into the Union or in a State Registered Union which is associated with the Union and a passport size photograph of the candidate. (Statements are preferred by email to: vicelections@aec.gov.au)
