Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

#### **Withdrawing Nominations**

Nominations cannot be withdrawn after 5:00pm Australian Eastern Daylight Time (AEDT) on 26/10/2018.

**Candidates' Statements (Rule 47.52):**

Candidates are advised that they may, at the time of nominating, not later than 5:00pm (AEDT) on Friday 26 October 2018 submit to the Returning Officer, a typewritten statement which shall not exceed 200 words and a list of offices and /or positions currently and/or previously held in the Union or in any Union which is amalgamated into the Union or in a State Registered Union which is associated with the Union and a passport size photograph of the candidate. Statements are preferred by email to [nswelections@aec.gov.au](mailto:nswelections@aec.gov.au); as a word doc. and photographs sent as a jpeg.

**Voting Period**

The ballot, if required, will open on 16/11/2018 and close at 10:00am Australian Eastern Daylight Time (AEDT) on 14/12/2018.

**Scrutineers**

Candidates may appoint a scrutineer in accordance with Rule 47.50 of the Union's rules. The appointment of scrutineers closes 10:00am Australian Eastern Daylight Time (AEDT) on 14/12/2018.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
